7. Feedback from Patrols and Community Watch:

Sector 2 had 17 incidents.

Sector 3 had 11 incidents.

Sector 4 had 5 incidents.

Sector 5 had 22 incidents.

Most incidents on a Saturday, Sunday and Wednesday.

8. Law Enforcement Feedback: Asst Sup. Asogan Reddy

The stats for the month were shared:

228 by-law violations were issued.

553 parking violations were issued.

4 business inspections were done.

5 Crime prevention OPS were held in the area.

9 roadblocks were held, 3 vehicles removed from the road.

21 Motor vehicle accidents were attended to.

284 written notices were issued.

There was protest action in Port Shepstone (Education Dept.) as well as a taxi strike on 29/30 July, and many activities were held for Women's Month.

LE was involved in a Shebeen raid where illegal alcohol was removed, and foreign nationals arrested.

The main Harding Road is now open, and the Port Shepstone mall is scheduled to open in October.

The training of the new recruits began on 1 July. 9 of the recruits will be joining Port Shepstone sector.

Leila queried if any fines have been issued for the drinking offences that were reported on Tweni Beach. Asst Sup. Asogan Reddy replied that members had attended the incidents, but he had not received feedback.

Asst Sup. Reddy gave Feedback of the accident where a vehicle crashed into an Eskom Minibus. The driver was not under the influence. She lost control of her vehicle.

9. SAPS Feedback:

Captain Kodi reported that there were 5 housebreaking incidents and 1 Theft out of a Motor Vehicle incident reported in August. This is an increase from last month. Please remain vigilant.

10. Umzumbe Farmers Association Report: Rod Hackland

Arrests have been made in the case of mob justice where an innocent young man was killed and badly.

2 suspects from a group of known Whoonga users were arrested after being seen on the cameras. They have been linked to 3 cases other cases in the area and a firearm was recovered. Rod gave thanks to Buffelskloof Security.

11. UIP (Umtentweni Improvement Project):

A public meeting was held on 5 August at the Tweni Library for residents that were not able to attend evening meetings. Another meeting with Complex managers is to be held on 2 September.

Votes in so far = 394, 301 Yes votes and 93 No votes. Please submit your votes.

12. General:

There has been an increase in general vandalism in Tweni. Signs and poles have been knocked down as well as the benches at the Whale Deck damaged. This is probably due to the increase of drunken behaviour in the area. Captain Kodi will try support as much as possible.

Patrollers reported that SAPS has been seen doing patrols in the area and were also first on scene when the fires were reported in the area.
